## Down to the Finish Line: Less Than One Week Remains for DEIS Comments

The April 6 deadline for commenting on the Draft Environmental Impact Statement (DEIS) for the Atlantic Coast Pipeline (ACP) is less than a week away. Submitting comments for the DEIS is <u>the</u> most important action someone can take to influence the decision of the Federal Energy Regulatory Commission (FERC) regarding the Atlantic Coast Pipeline. Even if someone testified at one of the recent FERC comment sessions, they are urged to also file written comments, permitting them to provide more expansive views. To assist commenters, ABRA has prepared a guidance document: <u>The Draft Environmental Impact Statement for the Atlantic Coast Pipeline</u>: What is it? What's in it? What you can do!

Here's how comments can submitted:

- 1. File comments electronically (which is encouraged) using the eComment feature on the Commission's website (www.ferc.gov) under the link to Documents and Filings. This is an easy method for submitting brief, text-only comments on a project.
- 2. File comments electronically by using the eFiling feature on the Commission's website (www.ferc.gov) under the link to Documents and Filings. With eFiling, one can provide comments in a variety of formats by attaching them as a file with your submission. New eFiling users must first create an account by clicking on "eRegister."
- 3. File a paper copy of comments by mailing them to the following address:

## ABRA Writes Virginia and West Virginia State Legislators

Members of the West Virginia Legislature and the Virginia General Assembly have been told of major problems with the Atlantic Coast Pipeline (ACP) in letters written to them by ABRA on March 30. The letters were sent in the context of an effort by Dominion Energy to have state legislators send endorsements of the ACP to the Federal Energy Regulatory Commission (FERC). The separate letters to the West Virginia and Virginia state legislators argued that:

• <u>The ACP is not needed</u>. Numerous studies have warned of overbuilding of natural gas pipelines in the East letter. New forecasts reduce the expectations for future generating

requirements for areas to be served by the ACP, thus diminishing the amount of natural gas claimed by the project's sponsors to be needed. Furthermore, two-thirds of the new generating capacity being built in the country is based on solar and wind energy, while the percentage of new capacity generated by natural gas has reduced significantly.

- The claims of new jobs that would be created by the ACP are grossly exaggerated. The sponsors of the ACP claim that the project "holds the promise of thousands of new jobs." This is not true! Most construction jobs created by the ACP will be temporary and held by out of state contract employees. The small number of permanent jobs created by the ACP in each state is offset by the economic harm that would be dealt to existing businesses. (Specific examples in each state are cited).
- Serious and permanent harm to Virginia's natural resources would result from the ACP. Dominion's claim that the ACP would pose no threat to the integrity of natural resources is a myth. Informational filings on the project make it increasingly clear that the quality of water resources will be seriously compromised by the ACP. Furthermore, a just-completed study by our coalition has concluded that a cumulative total of 38 miles of mountaintops and adjacent ridgetops (19 miles in each state) would be removed by ACP construction.
- The ACP would not serve the public good. Should the ACP receive approval from FERC, it would be granted the right of eminent domain to take private property for private gain. When a project is 1) not needed, 2) would result in negative economic impacts to affected businesses, communities and landowners, and 3) would bring serious and permanent damage to each state's natural resources, it is not in the best interest of the citizens of either state.

## **Augusta Board of Supervisors Raises Serious Questions With DEIS**

The many deficiencies of the Draft Environmental Impact Statement (DEIS) were strongly criticized in a <u>March 28 letter</u> to Cheryl A. LaFleur, Acting Chairman of the Federal Energy Regulatory Commission, by the Augusta County, VA Board of Supervisors. Supervisors Chairman Tracy Pyles said:

After our review of the DEIS, we are concerned with the documents continual acceptance of Atlantic submitted plans and procedures as sufficient in mitigating adverse impacts. We believe that the DEIS is essentially a summarization of Atlantic's claims, figures, and numbers rather than a critical analysis in which these claims are thoroughly vetted for their comprehensiveness, evaluated independently and verified for accuracy.

The letter proceeds to cite specific examples of missing or incorrect analysis on alternative routes, traffic impact, urban service areas (under the county's comprehensive plan), agriculture, landfill sites, water sources and karst. In the conclusion to his letter, Chairman Pyles said:

In conclusion, we would like to reference a recent ruling by a federal judge that Dominion's coal ash site in Chesapeake, Virginia is leaking arsenic and is in violation of the Clean Water Act. This revelation demonstrates that mitigation plans are not always sufficient in reducing negative environmental and health/safety impacts to "less than significant levels." It also demonstrates the vigilance that is necessary on the part of assessment, permitting and enforcement agencies to protect the environment and public health. We hope that the Final Environmental Impact Statement will embody such vigilance and answer the questions we have detailed above.

## New Story Map Highlights Potential Harm to Shenandoah Mountain

A new story map entitled "Proposed Shenandoah Mountain National Scenic Area and the ACP" is now available. Produced by Lynn Cameron of ABRA member Friends of Shenandoah Mountain, the piece points out that "a permanent corridor of this magnitude could degrade the natural and scenic characteristics of the proposed National Scenic area to the point where it could jeopardize its viability for Congressional designation."
