# **Buppert of SELC Testifies on National Energy Security Corridors Bill**

Greg Buppert, Senior Attorney for the Southern Environmental Law Center, a member of ABRA, testified May 20 before the U.S. House Subcommittee on Energy and Mineral Resources on the significant impacts that natural gas pipelines crossing federal lands would have on the surrounding local communities and private property. The proposed National Energy Security Corridors Act, H.R. 2295, would allow pipelines to be sited through federal lands without providing the general public an opportunity to weigh in. Buppert said: "What we need right now in Virginia is a regional plan. First we need to know whether the demand for natural gas can justify the impacts of new pipeline infrastructure in our state. Any proposed route should be planned with input from the public and provide the greatest protections possible to private property, local communities, and the environment of the entire region." # **DPMC Asks Governor For Transparent Environmental Information on ACP**

Virginia Governor McAuliffe was asked "to provide unrestricted public access to critical environmental information concerning the proposed Atlantic Coast Pipeline" in a May 21 letter from Rick Webb, Coordinator of the Dominion Pipeline Monitoring Coalition. Webb said that DPMC, an ABRA member, specifically requests "that the DEQ (VA Department of Environmental Quality) obtain site-specific erosion and sediment control and stormwater management plans prior to issuing any approvals or accepting any permit submissions for the ACP. And we request that the DEQ make these plans available to local governments and the public." The complete letter is available at
