# VA Water Control Board Conditionally Approves ACP

The conditional approval of a water quality certificate for the Atlantic Coast Pipeline (ACP) by the Virginia State Water Control Board on Tuesday afternoon, December 12, capped a two-day meeting that varied from moment to moment between serious presentations and deliberations and utter confusion exhibited by the staff of the Department of Environmental Quality. For those persons present for the proceedings, it was a regulatory roller coaster ride.

The Board agreed by a 4-3 vote to approve certifying the ACP under Section 401 of the Clean Water Act, subject to the completion of several outstanding plans yet to be submitted in final form by the applicant. The final language of the Board's action has at this writing not been posted on the DEQ webpage for the ACP project. But, according to information available at the meeting, the following appears to be the relevant operative language in the motion adopted by the Board:

"This certificate shall be effective only following submission, review, and final approval as required by law of the Karst Mitigation Plan, Annual Standards and Specifications, Stormwater Plans, and Erosion and Sediment Control Plans, and a report to the Board and the public by DEQ on the adequacy of these materials. The Board may consider further actions on the Certification following the review of the DEQ report."

DEQ staff has indicated that the required reports may not be completed and submitted for review until March or April 2018. Staff has also said that construction cannot begin "until the final erosion and sediment control plans are approved." Further analysis of the State Water Control Board decision is being conducted and will be reported on in forthcoming issues of *ABRA Update*.

# **MVP Certification Decision Challenged in Court**

Following last week's decision by the Virginia State Water Control Board to grant Section 401 water quality certification for the Mountain Valley Pipeline, a group of ABRA members filed suit against the Water Control Board and the Department of Environmental Quality. The <u>Petition for Review</u> was filed with the U.S. Court of Appeals for the Fourth Circuit (Richmond) by the Sierra Club, Appalachians Voices, Chesapeake Climate Action Network and Wild Virginia, represented by Appalachian Mountain Advocates. Initial briefs are to be filed next month.

# **Governor-Elect Northam Announces Key Appointments**

Virginia Governor-Elect Ralph Northam announced December 14 his appointments for two key members of his cabinet: Secretary of Natural Resources and Secretary of Agriculture and Forestry:

<u>Matt Strickler, Secretary of Natural Resources</u> – Matt Strickler serves as Senior Policy Advisor to the House Committee on Natural Resources under Democratic Ranking Member Raúl Grijalva (AZ-3). His portfolio includes fisheries, oceans, wildlife, and coastal policy, as well as related energy and public lands issues. He also handles matters related to The National Environmental Policy Act (NEPA). Originally from Lexington, Va., Matt graduated from Washington and Lee University and holds master's degrees in public policy and marine science from the College of William and Mary and the Virginia Institute of Marine Science. He was a Knauss Marine Policy Fellow in NOAA's Office of International Affairs in 2007, and worked on U.S. Senator Mark Warner's successful 2008 campaign. Immediately prior to joining the Committee in 2012, Matt worked in the Virginia General Assembly as a legislative assistant to then-state Senator Ralph Northam.

<u>Bettina Ring, Secretary of Agriculture and Forestry</u> – Bettina Ring was appointed State Forester by Governor Terry McAuliffe in 2014. Prior to that, Ms. Ring served as Senior Vice President of Family Forests at the American Forest Foundation where she was responsible for overseeing the American Tree Farm System®, the largest and oldest sustainable woodland program in America, supporting more than 80,000 family forest owners collectively managing 27 million acres of certified woodlands. Ms. Ring has a long history in the conservation and forestry sectors, having spent 14 years at the Virginia Department of Forestry, departing the agency in 2001 as Deputy State Forester. In her role, Ms. Ring was responsible for operations, and helped to develop and implement a new mission, vision and strategic plan for the department. In the years following her Department of Forestry service, Ms. Ring held various leadership positions within nonprofit organizations focusing on natural resources management and conservation, including the Colorado Coalition of Land Trusts, The Wilderness Land Trust and the Bay Area Open Space Council. Ring holds a Bachelor's degree in Forestry and Wildlife from Virginia Tech and a Master's degree in Business Administration from James Madison University.
