Rockbridge Planning Commission to Consider Approval of ACP Yard

A proposed storage vard for the Atlantic Coast Pipeline will be the subject of a May 13 meeting of the Rockbridge County (VA) Planning Commission to discuss its possible approval. This issue was discussed in the April 30 issue of ABRA Update. The proposed contractor vard, to be located in Goshen, VA, would be an active hub for pipe welding, fuel storage, pipeline worker rendezvous, material storage, and construction vehicle travel to pipeline installation locations in neighboring Bath, Highland, and Augusta counties.

FERC Process Skewed Against Landowners, Says Congressional Committee

Rep. Jamie Raskin (D-MD), Chairman of the Subcommittee on Civil Rights and Civil Liberties of the U.S. of Representatives, released on April 28 preliminary findings showing that the natural gas pipeline approval process used by the Federal Energy Regulatory Commission (FERC) unjustly tramples on the rights of private landowners. The subcommittee report concluded:

- FERC rubber-stamps pipeline projects. Only 6 out of more than 1000 projects have been • rejected in the past 20 years.
- Landowners are prevented from defending their property against pipeline companies. FERC has issued a tolling order in every case where a landowner has requested a hearing, thus delaying the consideration of appeals, often until after a project is completed.
- FERC favors pipeline companies. Among 114 requests for rehearing over the past 12 years, FERC has authorized 64% of the time construction of a pipeline project before ruling on a rehearing request.

The subcommittee issued in conjunction with the release of its report a 12-minute video that features Richard Averitt of Friends of Nelson County, an ABRA Member, and Maury Johnson, a West Virginia landowner and Board member of the POWHR coalition that is leading the fight against the Mountain Valley Pipeline. Dominion Expresses Optimism About ACP in Call with Financial Analysts

Dominion Energy reiterated this week its expectation that construction activity on the Atlantic Coast Pipeline will resume later this year, that its overall cost will be in line with the latest \$8 billion estimate and that the pipeline will be in full service in 2022 These projections were made by CEO Tom Farrell during a May 5 quarterly earnings conference call with financial community analysts. Farrell said:

"We can maintain the existing schedule and cost estimates so long as we can take advantage of the November 2020 through March 2021 tree felling season. We will continue to monitor and provide communication to investors as appropriate. Based on these expectations, we remain confident in the successful completion of the project and note that there are no changes to the financial contribution estimates for 2020 and beyond."

Regarding the status of some of ACP's vacated permits, Farrell said:

"Next, the biological opinion. Progress continues, despite COVID as we provide information that is responsive to request from both FERC and the Fish and Wildlife Service. We expect the authorization to be reissued by the end of this quarter, that period would mark nearly a 12 - a full 12 months since the court invalidated the prior version in July 2019. Demonstrating the rigor with which the permitting agencies are approaching resolution of the concerns identified by the court.

"In the case of the air permit for Buckingham Compressor Station, we've already begun to submit additional data and analysis to the Virginia department of environmental quality, which we believe provides ample justification for the original air board decision to approve the strictest minor source air permit in the nation and addresses all the concerns voiced by the court. We expect the permit to be re-issued by year end.

"Finally, with regard to the nationwide permit 12, which is issued for the project by the United States Army Corps of Engineers, we had expected the permits to be re-issued shortly after the issuance of the biological opinion, as the core in recent months has taken steps that address the four circuits concerns. The recent decision related to the Keystone pipeline by the district court in Montana has potential implications for nearly all critical infrastructure investment and associated employment across the country. . . With regard to ACP, we believe it is too early to tell what if any impact this ruling will have on the existing and timing and cost of the projects which are otherwise affirming today."

New EPA Navigable Waters Rule Challenged in Court

A group of conservation organizations on April 29 filed a lawsuit in the U.S. District Court of South Carolina, Charleston District, challenging the <u>Trump Administration's Navigable</u> <u>Waters Protection Rule</u>, which was published as a final rule on April 21. The rule would redefine what wetlands and streams qualify for protection under the Clean Water Act. It is estimated that half of the nation's wetlands and nearly $1/5^{\text{th}}$ of its streams would lose Clean Water Act protection. The rule, which was jointly issued by the U.S. Environmental Protection Agency and the U.S. Army Corps of Engineers, is to become effective June 22, 2020.

The suit was filed by the Southern Environmental law Center (SELC) on behalf of a coalition of conservation groups that includes the James River Association, an ABRA member. A similar lawsuit challenging the new law was filed in U.S. District Court for the District of Massachusetts by another coalition of conservation organizations that includes the Natural Resources Defense Council, also an ABRA member.

The lawsuit contends that the agencies' wholesale stripping of protections was an unlawful departure from decades of bipartisan practice. Among other things, the agencies failed to explain or evaluate the impact of their actions on the nation's water quality or give Americans a meaningful opportunity to comment on the elimination of scientifically based protections for streams and wetlands. The suit further argues that the challenged rule ignores the intent of the Clean Water Act, which a bipartisan Congress passed in 1972 because state-by-state efforts to clean the nation's waters failed.
