### **ACTION ALERT:** Comments Due August 3 on ACP & SHP Time Extension

Comments are due by <u>5 pm</u>, <u>Monday</u>, <u>August 3</u> on the request by Dominion Energy Transmission, Inc. (DETI), submitted to the Federal Energy Regulatory Commission (FERC) on July 10, for an extension of time of 1) one-year to address abandonment and restoration issues for the Atlantic Coast Pipeline, and 2) two-years to complete construction of the Supply Header Project (SHP). The major points that should be made in comments are:

- The SHP time extension should be denied because it has not and cannot be justified in accordance with FERC standards. The project was proposed as being dependent upon the Atlantic Coast Pipeline (ACP). Dominion Energy clearly stated on the record that "the SHP does not have independent utility and would not be built without construction of the ACP." If built, the SHP would be a <u>pipeline to nowhere</u> because the ACP project is dead!
- The extension request for the ACP to address abandonment and restoration activities along the project's right-of-way should not be granted without a public comment period of at least 30-days. It is in the Commission's interest to know the concerns that the public and affected landowners have about restoration activities and impacts on landowners' rights in the future.
- Landowners who entered into an easement agreement with Atlantic Coast Pipeline, LLC (Atlantic) should be provided an opportunity to be released from those agreements as a condition of FERC's granting Atlantic its requested extension so that the landowners can once again utilize their land without the restrictions such agreements placed upon future use. The recommendation for such a remedy, made in a July 17 filing by a group of conservation organizations (cited below), should be adopted by FERC.

"Requiring Atlantic to promptly contact all landowners where a right-of-way easement exists and inform them that (i) Atlantic will release the right-of-way easement within 90 days of a written request from an affected landowner, (ii) Atlantic will provide the affected landowner with the proposed written release of the right-of-way easement, (iii) Atlantic will pay the reasonable attorneys' fees of the affected landowner in reviewing and negotiating changes to the proposed written release of the right-of-way easement, and (iv) Atlantic will file the final, executed written release of the right-of-way easement in the land records of the appropriate jurisdiction. Atlantic has already committed that landowners will keep the easement compensation they have received."

FERC's agreement with this recommendation would be in keeping with the recently expressed interest by Chairman Chatterjee of the Commission being more response and sensitive to the interests and concerns of landowners who are affected by projects being considered by the Commission.

#### **New NEPA Regulations Challenged in Court**

The Southern Environmental Law Center (SELC) filed a complaint July 29 with the U.S. District Court for the Western District of Virginia asking that the new regulations implementing the National Environmental Policy Act (NEPA), issued July 15 by the Council on Environmental Quality (CEQ), be set aside. The SELC filing, made on behalf of a group of conservation organizations that includes 5 ABRA members, charges that CEQ "disregarded clear evidence from over 40 years of past implementation; ignored the reliance interests of the citizens, businesses, and industries that depend on full and complete NEPA analyses; and turned the mandatory public engagement process into a paper exercise, rather than the meaningful inquiry the law requires."

Continuing, the complaint states:

By excluding a range of projects from any NEPA review, severely limiting the environmental effects that must be considered under NEPA, restricting which alternatives should be studied, and allowing projects to proceed before the NEPA process is complete, CEQ has eviscerated the heart of the statutory scheme. Because CEQ has arbitrarily reversed longstanding regulations, contrary to the administrative record and the governing statute, its rulemaking violates the APA [Administrative Procedures Act] and must be vacated.

#### Forest Service, Park Service Move Toward Reissuing New MVP Permits

The U.S. Forest Service (NFS) <u>published on July 30 a Notice of Intent</u> to prepare a Supplement Environmental Impact Statement (SEIS) for the Mountain Valley Pipeline (MVP) "to address the Fourth Circuit Court's ruling, new information, and changed circumstances such as new Federally listed threatened and endangered species and critical habitat designations." The draft SEIS is expected to be available in September, with the final SEIS completed later in 2020. The NFS announcement follows a <u>July 16 notice by the U.S. Park Service</u> that it will be issuing a new right of way permit for the MVP to cross Park Service land.

#### **MVP Completion Percentage is Overstated**

The owners of the Mountain Valley Pipeline (MVP) have repeatedly proclaimed that over 90% of the project has been completed, no doubt to bolster confidence from their investors and stockholders so that they continue investing. An examination by ABRA of the data reported by MVP to the Federal Energy Regulatory Commission reveals that project completion claims are overstated. Only 51% of the 300-mile route has pipe in the ground and the ground above it restored. In Virginia, which has one-third of the MVP route, less than 15% of the route has undergone final restoration.

#### **Two New FERC Commissioners Nominated**

President Trump has nominated two new Commissioners to serve on the Federal Energy Regulatory Commission. Mark Christie, chairman of the Virginia State Corporation Commission for the past 16 years, was nominated to fill the seat of departing Commissioner Bernard McNamee, a Republican member. Allison Clements, now with the Energy Foundation and formerly an attorney with the Natural Resources Defense Council, was appointed to fill the seat vacated last summer by Cheryl LaFleur, a Democrat.

The President sent required paperwork on the two nominees to the U.S. Senate on July 29, but it is uncertain how soon the nominations will be considered, but it presumably will not be until after Labor Day. The Senate is scheduled to begin a month-long recess on August 10, returning to session on September 8.
