Coalition seeks to educate investment community about funding MVP

Leading credit rating firm voices concerns about the MVP

Fitch Ratings, one of the leading firms that provides credit ratings, commentary and economic research, has voiced doubts about the viability of the Mountain Valley Pipeline. In a January 28 issue of its *Fitch Wire*, the firm stated:

President Joe Biden's executive order that revoked Keystone XL's Presidential Permit may be an indicator of his administration's aversion to long-distance projects in US midstream energy, says Fitch Ratings. We believe Energy Transfer's Dakota Access Pipeline (DAPL), Equitrans Midstream's Mountain Valley Pipeline (MVP) and Enbridge's Line 3 Replacement are at risk of interference. Interference could have credit implications for the midstream energy companies involved in these projects but would be considered on an individual issuer basis.

Equitrans' operating subsidiary EQM Midstream (BB/Negative) continues to experience delays and cost overruns with MVP due to environmental and regulatory challenges, including securing permits, which has led to a Negative Outlook. The in-service date is now expected to be late 2021. EQM plans to modify MVP's construction program because of the Fourth Circuit Court of Appeals ruling on a topic pertaining to the Army Corps of Engineers. Fitch remains concerned about execution of the project. EQM's earnings growth and the strengthening of its balance-sheet metrics are largely dependent on the completion of MVP.

Legislation on gold mining progresses in Virginia General Assembly


A bill that would direct state agencies to evaluate the environmental threats posed by gold mining in Virginia was approved February 5 by the Virginia House of Delegates. The vote was 55 in favor, 45 against. HB 2213, a measure spearheaded by ABRA member Friends of Buckingham, was in response to a proposed gold mine in Buckingham County (click here and here for earlier ABRA Update stories; also, click here for further information about the issue on ABRA's website). The bill would prohibit until July 1, 2024 the issuance of a permit for gold mining an area larger than 10 acres. The measure now heads to the Virginia Senate for its consideration.

The legislation is relevant for more than just Buckingham County, as the seam of gold underneath Buckingham County extends for a good portion of the state, north and south of Buckingham. As discussed in the previously referenced information links, gold mining operations are <u>very</u> threatening to the environment, particularly water quality. In the case of the proposed Buckingham mining site, water quality in the nearby James River would be seriously compromised should the mining operation be undertaken. <u>ABRA members are strongly urged to contact their state Senators and urge their support for and enactment of HB 2213.</u>

Duke IRPs overstate likely future demand growth

Forecasts used by Duke Energy that predict steadily rising demand for electricity in the Carolinas ignore the company's sales history in the past 15 years, which have been essentially flat, and should be challenged by state regulators, according to a new study by the Institute for Energy Economics and Financial Analysis (IEEFA).



Dominion Energy's Integrated Resource Plan Deemed Insufficient

Dominion Energy's proposed integrated resource plan, filed with the Virginia State Corporation Commission (SCC) on May 1, 2020, has been rejected as insufficient. The plan was to have included information related to the Virginia Clean Economy Act (VCEA) enacted by the General Assembly in 2020. In its February 5 order, the SCC stated:

Under the VCEA, Dominion must engage in robust planning to achieve the policy goals therein in a cost-effective manner. The Commission recognizes that Dominion did not have an extended opportunity to conform its 2020 IRP to address all the interrelated aspects of recent legislation. The Commission, however, cannot conclude, based on the record in this proceeding and issues discussed further below, that Dominion's 2020 IRP, as filed, is reasonable and in the public interest for purposes of a planning document.

The Commission will meet on February 12 at 10 am and provide an opportunity for public testimony on the issues raised by the February 5 order (<u>PUR-2020-00134</u>).
