### Release of final SEIS for ACP restoration is delayed

The Federal Energy Regulatory Commission (FERC) has announced a revised schedule for releasing a final Supplemental Environmental Impact Statement (SEIS) and making a final decision on the restoration plan that had been submitted for the nowcancelled Atlantic Coast Pipeline. Originally, FERC had announced it would release the final SEIS on November 19 and make a decision on the plan by February 17. According to a November 19 Notice, the final SEIS will now be issued December 17, 2021. The new decision deadline is March 17, 2022.

### Key decisions on MVP to be made soon

Several key decisions are due to be made soon concerning necessary permits for the Mountain Valley Pipeline (MVP). Here's a review of some key dates:

- Army Corps of Engineers consideration of a 404 permit for the MVP to cross streams and rivers – deadline for comments is 11:59 pm, November 19. For info on filing comments, click here.
- Virginia State Water Control Board meeting on issuing a 401 certificate for the MVP is scheduled for December 14 in Richmond, VA. For available information, click here.
- West Virginia Department of Environmental Protection is due to make a decision about on a 401 certificate for the MVP by November 29.
- Virginia Air Pollution Control Board meets on December 2 and 3 in Chatham, VA to consider an air permit for the MVP Lambert Compressor Station. Details here and here.





### Senate confirms new FERC Commissioner

Willie Phillips has been confirmed by the U.S. Senate to be a member of the Federal Energy Regulatory Commission (FERC). The November 16 action was on a voice vote. Phillips has been Chair of the District of Columbia Public Service Commission and before that was assistant general counsel for the North American Electric Reliability Corp. His confirmation paves the way for Democrats to control FERC, there now being 3 Democrat members and 2 Republicans. President Biden earlier this summer named Democrat member Richard Glick to be FERC Chair.

#### New Director of the National Park Service is confirmed

Charles Sams was confirmed as the new Director of the National Park Service on a voice vote by the U.S. Senate on November 18. Sams has been a member of the Northwest Power and Conservation Council and has served as Executive Director of the Confederated Tribes of the Umatilla Indian Reservation. An Oregon native, he is the first Native American to lead the Park Service.
