# **ABRA Update #41 – August 11, 2015**

#### **Dominion CEO Briefs Security Analysts**

Dominion CEO Thomas Farrell conferred with 8 security analysts in an August 5 conference call to discuss the company's 2nd quarter earnings. Regarding the Atlantic Coast Pipeline, Farrell said:

"We're continuing to work towards the commencement of construction on the Atlantic Coast Pipeline and the related Supply Header Project.

"We began the FERC filing process last November and expect to make the formal filings in September. Surveying is about 80% complete and engineering is about 70% complete. We awarded the large diameter pipe manufacturing contract in January to Dura-Bond Industries of Pennsylvania and expect to award small diameter pipe contract in August.

"Construction bids were received in May. And we expect to conclude negotiations by the end of the summer, well ahead of our original project plan. We plan to begin construction on both projects in the fourth quarter of 2016 and commence operations in November 2018."

During the question and answer period with the analysts, a question regarding the ACP came up in the following exchange:

Shahriar Pourreza - Guggenheim Securities LLC

"And then just lastly in Atlantic Coast, are we still comfortable at 1.5 Bs per day or are we still – is there an opportunity to upsize that?

Thomas F. Farrell ll - Chairman, President, and Chief Executive Officer

"It's signed up for 1.5 now. And I think we've said previously that it's easy to expand it to 500 a day just by adding some pressure. So, we're still obviously in the pre-filing process but we'll file that formally next month."

In a recent posting in the *Marcellus Drilling News* (MDN) website, the July 30 National Forest Service comments (<u>http://abralliance.org/wp-</u> <u>content/uploads/2015/08/NFS</u> comments on ACP Resource Reports 1-10 7-30-15.pdf) on Dominion's draft Resource Reports 1-10 on the Atlantic Coast Pipeline were dismissed as merely the views of "a single U.S. Forest Service worker." The comments in question were signed by H. Thomas Speaks, Jr. Supervisor of the George Washington and

Jefferson National Forests, and filed on behalf of the GWNF and the Monongahela

National Forest. The MDN went on to claim that Speaks was "fed anti-pipeline propaganda from the head of an anti-pipeline organization," noting that the Forest Service comments echoed talking points raised in comments that Rick Webb of the Dominion Pipeline Monitoring Coalition had filed with the agency.
