FERC Staff Comments on ACP Draft Plan

The staff of the Federal Energy Regulatory Commission has responded to the July 27 filing by the Atlantic Coast Pipeline on a series of draft plans required by the agency on: 1) Karst Terrain Assessment, Construction, Monitoring and Mitigation; Spill Prevention, Control and Countermeasures; Blasting ; Winter Construction; and Invasive Plant Species Management. The comments make 38 separate requests for further information or clarifications from ACP, nearly half of which concern the draft plan on Invasive Plant Species Management.
