## ABRA Update #47 – September 24, 2015

#### Now That ACP Has Filed, What Happens Next?

The Atlantic Coast Pipeline's September 18 filing with the Federal Energy Regulatory Commission has now set in motion formal evaluation of the project, including the conducting of an Environmental Impact Statement and consideration of the market need for the pipeline. That process can be expected to last a year, perhaps longer. The new docket number for the project is **CP15-554**. For those organizations and individuals considering filing for intervenor status, it must be done within 21 days from the publication of the notice in the Federal Register. As of 9/25/15, the notice of ACP's filing has not been published.

One question that has recently been raised by several people concerns whether comments filed with FERC during the pre-filing period need to be refiled. Kevin Bowman, FERC's environmental project manager for the project, e-mailed ABRA Steering Committee member Charlotte Rae that previously filed comments do not need to be re-filed:

"All comments filed under BOTH the PF15-5 and PF15-6 are considered part of the complete record for the SHP and ACP projects. Any and all comments filed during pre-filing do NOT need to be filed again under the CP15-554 or CP15-555 dockets. Please feel free to share this information with anyone who has the same question as you do."

ABRA's Steering Committee conferred on 9/24/15 and has begun to craft strategies to respond to last week's ACP filing. One program that is being launched is discussed below.

### ABRA to Conduct In-Depth Review of ACP Resource Reports, Help Needed

ABRA's Steering Committee has decided to conduct a thorough review of the Resource Reports that were included with the September 18 application submitted to FERC. An initial examination of the Resource Reports reveals a good deal of informational shortcomings. ABRA wishes to identify the specific inadequacies and missing elements of the Resource Report filings. We are assembling a team of people to assume review assignments. Charlotte Rae, a Steering Committee member, will oversee the review project, assisted by Dan Shaffer, ABRA Communications Coordinator.

Persons associated with ABRA member organizations can help by taking on a review assignment, as follows:

- 3. You will receive by September 30 your assigned Resource Report and guidance on the criteria to be used to review the assigned report. Your report will be due by October 6.
