Pipeline Summit Set for November 12 at Natural Bridge Hotel

The second Pipeline Summit, co-sponsored by the Allegheny-Blue Ridge Alliance and the POWHR coalition (Protect Our Water, Heritage, Rights) will be held on Saturday, November 12 at the Natural Bridge Hotel, located just off of I-81, 20 minutes south of Lexington, VA. The first Pipeline Summit, held in April in Weyer's Cave, VA, was attended by 120 people. The November 12 event is expected to draw a larger crowd, which will include representatives from groups in North Carolina who are in opposition to the Atlantic Coast Pipeline.

The <u>Natural Bridge Hotel</u> is one of Virginia's and the nation's most historic hotels. It sits on a site where Thomas Jefferson built a cabin with a guest room and is located 500 yards from the famed Natural Bridge, a National Historic Landmark.

Some of the topics that will be addressed at the Summit include:

- Latest developments and outlooks for the ACP & MVP;
- Impact of the November 8 election results;
- Recent studies on karst, water monitoring and soil erosion;
- Economic studies on the need for new pipelines;
- Legal strategies; and
- Strengthening our efforts.



The Summit will begin at 10 am on November 12 and conclude by 3:30 pm. There will be plenary and breakout sessions. A \$10 fee will be charged for lunch and beverages. A small block of rooms has been set aside for those needing overnight accommodations, at \$79/ per night.

The Summit agenda is being developed by a joint ABRA-POWHR planning committee. Program and registration information will be sent soon. For now, MARK YOUR CALENDARS!

VOF Voices Opposition to the ACP Route Proposal

The Virginia Outdoors Foundation (VOF) has asked the Federal Energy Regulatory Commission (FERC) to not approve the latest proposed route change proposed in Nelson County, VA for the Atlantic Coast Pipeline (ACP). In a <u>September 6 letter to FERC</u>, Martha Little, VOF Deputy Director, said:

The GWNF-6 route change to avoid U.S. Forest Service lands resulted in significant potential impacts to VOF open-space lands. If this additional route change (Spruce Creek Route Variation) is adopted, a total of 11 open-space easements in Highland, Bath and Augusta and Nelson Counties would suffer permanent impairment of conservation values. These properties include areas of high ecological integrity, high priority conservation area forests, critical karst resources, scenic protected areas, pristine trout streams and important historic resources.

As FERC is specifically responsible for preventing and minimizing environmental impacts from natural gas projects, we urge you to reject the Spruce Creek Route alternative as a viable option and not include it in the DRAFT EIS. We would also implore you to reconsider the primary route that will cross 10 other VOF open-space easements.

New Story Map Available on National Forests and the ACP

"The ACP and Our National Forests" is the newest in the series of story maps developed and available on the Dominion Pipeline Monitoring Coalition website. It discusses through text and maps the existing corridors that exist to accommodate other utility projects and illustrates the significant impact the Atlantic Coast Pipeline would have on the George Washington and Monongahela National Forests, as well as upon the Appalachian Trail.

Other story maps are available discussing access roads, forest fragmentation, shale barrens and the impact of the ACP on environmental easements held by the Virginia Outdoors Foundation. Additional story maps are in the works and will be announced in the near future.

Forest Service Comments Further on ACP Impacts

Impacts of the Atlantic Coast Pipeline (ACP) on National Forest Service lands were the subject of further comment in two filings by the U.S. Forest Service published September 7. The first filing comments on an interim botanical survey report filed by Dominion Transmission, Inc. for the Monongahela and George Washington (GWNF) National Forests in July. The other filing addresses an August survey report on locally rare species in the GWNF.

Dominion Submits Updated WV Water Quality Application for ACP

An <u>updated application for a water quality permit</u> from the State of West Virginia for the Atlantic Coast Pipeline, as required by Section 401 of the Clean Water Act, was been filed August 26 by Dominion Transmission, Inc. with the WV Department of Environmental Protection (WVDEP). The re-filing is in response to the WVDEP declaring an earlier application, filed last September, to be incomplete.
