### **ABRA Files Comments With FERC On ACP Soils Survey Fiasco**

ABRA submitted comments to the Federal Energy Regulatory Commission (FERC) on November 17 calling on the agency to reexamine the pending application of the Atlantic Coast Pipeline, LLC (ACPLL) and question the soil surveys conducted along the entire pipeline route. The United States Forest Service (USFS) had complained on November 5 to FERC that the ACPLL had misrepresented soils surveying it had conducted in October in the Monongahela National Forest in West Virginia. The USFS said that the company failed to follow appropriate surveying protocols or use qualified persons to conduct the surveying, and then misrepresented to the USFS the facts of the surveying. ABRA urged FERC to reject any data gathered in last month's surveying. Noting that soils testing is a crucial part of determining the environmental suitability of a proposed route, ABRA called the improper testing another example of corporate incompetence and strong evidence of purposeful deceit by ACPLL.

### **Meetings With EPA and FWS Requested**

Appalachian Mountain Advocates, an ABRA member, has requested individual meetings with regional directors for the U.S. Environmental Protection Agency and the U.S. Fish and Wildlife Service, to discuss "concerns and provide valuable information regarding major natural gas infrastructure projects proposed for construction in the Mid-Atlantic region." ### **New Dominion Economic Study Released**

Dominion Resources released on November 17 a new economic study claiming that the company's various energy infrastructure projects that are underway will "support an average of more than 11,900 jobs per year" in Virginia through 2020. The study, conducted by Chmura Economics & Analytics of Richmond, includes Dominion electric generation projects as well as the Atlantic Coast Pipeline. Chmura projects 53% of the new employment will be direct employment generated by projects under consideration, 20% will result from indirect economic activity resulting from the projects, and 27% will be "induced," that is "economic activity generated when the workers at the power station and their suppliers spend their income." ## ACP Makes Supplemental Filing

The Atlantic Coast Pipeline filed on November 13 with the Federal Energy Regulatory Commission supplementary information that includes the status of environmental, biological and invasive plant species surveys. The filing also identifies hydrostatic test water discharge locations on U.S. Forest Service lands. ABRA members are reviewing the filing regarding its implications.
