



## ***ABRA Update #105 – November 10, 2016***

### **A Full House for the Pipeline Summit**

175 persons have now registered to participate in the Pipeline Summit this coming Saturday, November 12, at the Natural Bridge Hotel and Conference Center. That's a 45% increase from the attendance at last April's Summit. Registration is now closed due to space limitations of the hotel. ### **A Trump Administration: What to Expect on Pipeline Issues**

The November 8 victory of Donald Trump as the next President raises major questions about how his Administration will approach issues related to the proposed natural gas pipelines that ABRA and the POWHR coalition are fighting. Details of Trump's plans for energy and environment issues and who he will appoint to administer them will be forthcoming in coming weeks. However, a review of Mr. Trump's October 22 speech in Gettysburg, PA, in which he outlined his action plan for his Administration's first 100 days in office, and postings on his new transition website (<https://www.greatagain.gov/>), provide relevant information:

- A requirement that for every new federal regulation, two existing regulations must be eliminated;
- Lift the Obama-Clinton roadblocks and allow vital energy infrastructure projects, like the Keystone Pipeline, to move forward;
- Cancel billions in payments to U.N. climate change programs and use the money to fix America's water and environmental infrastructure;
- Lift the restrictions on the production of \$50 trillion dollars' worth of job-producing American energy reserves, including shale, oil, natural gas and clean coal;
- Introduce the "American Energy & Infrastructure Act" that would leverage public-private partnerships, and private investments through tax incentives, to spur \$1 trillion in infrastructure investment over 10 years;
- Reduce and eliminate all barriers to "responsible energy production;" and
- Scrap the \$5 trillion dollar Obama-Clinton Climate Action Plan and the Clean Power Plan.

## **STOP the PIPELINE!**

The proposed \$5 billion Atlantic Coast Pipeline has been planned by Dominion Resources Duke Energy and to bring fracked gas from West Virginia, through Virginia and through Eastern North Carolina. It will endanger communities, homes, farms, wetlands and rivers along its entire 550 mile route through three states. In addition, it will contribute enormously to climate change and to extreme weather events like Hurricane Matthew, which devastated some of the counties which the ACP is proposed to pass through. Along the entire route, individuals, communities, and organizations are coming together to prevent its construction in a statewide alliance led by communities in the direct path of the pipeline.

In order to raise public awareness about the pipeline, and to give citizens an opportunity to speak out, there will be walks and rallies in three counties on Saturday, November 19. The walks will be organized under local leadership in Robeson, Cumberland and Nash Counties.

These three November walks will be followed in the spring of 2017 by a longer two week Walk along the 165 miles of the ACP pipeline route in North Carolina.

Each of the walks will have a large banner. In addition participants are encouraged to carry signs of 36 inches or less. Possible messages include: Stop the Pipeline; No ACP; Water is Life; Protect our Homes and Water. Etc. A 36" hula hoop can be used to show the size of the pipeline.
