

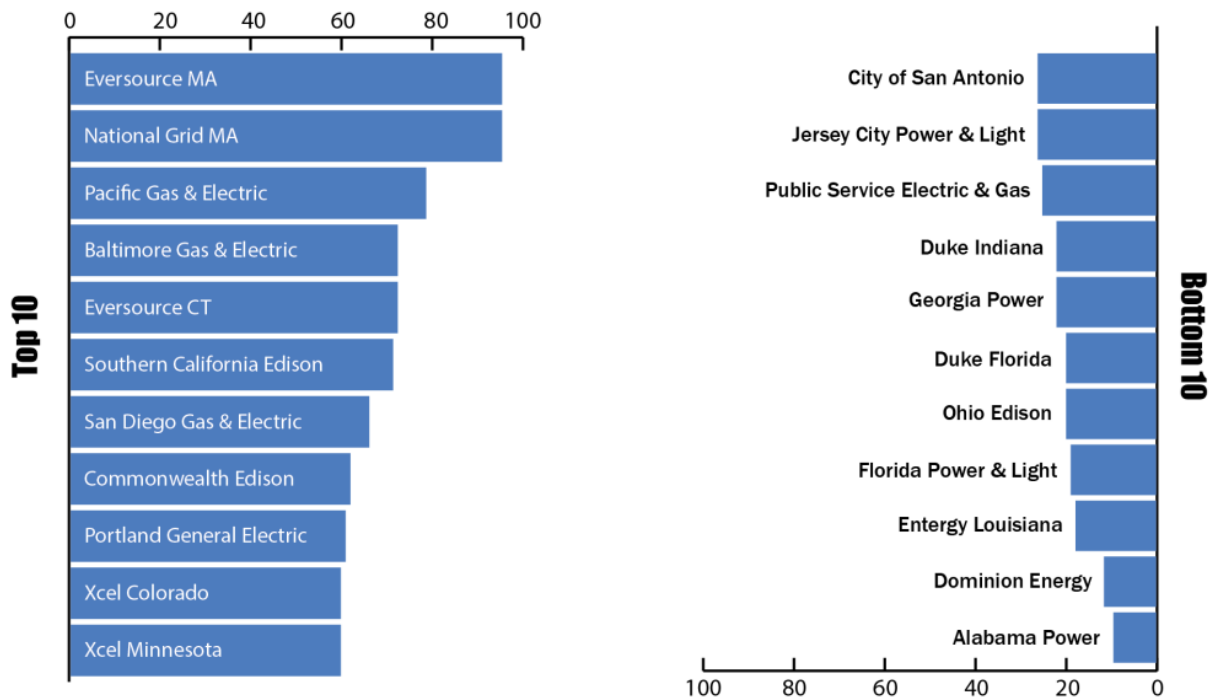

**New Utility Energy Efficiency Scorecard Out: Dominion at the Bottom**

Dominion ranks next to last in energy efficiency in a new study of the 51 largest U.S. electric utilities. The study, released June 13 by the American Council for an Energy-Efficient Economy (ACEEE), is the first in-depth study of its kind. In previous, less comprehensive studies, Dominion has also ranked quite low among the nation’s utility companies.

[Utility Energy Efficiency Scorecard](#) assesses the utilities across a range of 18 energy efficiency metrics in three categories critical to utility-sector efficiency: (1) quantitative savings and spending performance, (2) program diversity and emerging areas, and (3) targets, business models, and evaluation. The metrics used span a wide range of vital utility-sector efficiency programs and performance, each with a point value relative to its importance to utility-sector energy efficiency. Below is a list of the top and bottom ten companies and their scorecard rankings.

[ACEEE](#) is a nonprofit research organization that specializes in developing energy efficiency resources for public policy. The report received no utility funding. It specifically looks at state jurisdictional utilities rather than parent or holding companies. All 51 utilities were provided the opportunity to review the report before its publication.

### **Virginia DEQ Sets Forth 401 Review Criteria for ACP and MVP**

The Virginia Department of Environmental Quality has created a new webpage that describes how the agency is proceeding in its evaluation of the water quality certification applications for the Atlantic Coast Pipeline and the Mountain Valley Pipeline under Section 401 of the federal Clean Water Act.

The opening paragraphs, under the heading “Water Protection for Pipelines,” state:

Due to the size and scope of proposed natural gas pipeline projects in Virginia, DEQ is developing additional requirements to ensure that Virginia water quality standards are maintained in all areas affected by the construction of these pipelines.

DEQ will require Mountain Valley Pipeline and Atlantic Coast Pipeline to provide details and site plans to assess whether construction activities in adjacent areas will adversely affect water quality during construction and to ensure that water quality is maintained into the future. This additional certification goes well beyond other regulatory requirements and will protect water quality across the range of pipeline activities, not just temporary construction impacts to streams and wetlands.

### **Primary Reflections: Few Determined So Much**

This week’s Virginia gubernatorial primaries generated national attention (see article below from *The Hill* and *Politico*). Among the issues that received prominent attention, particularly in the Democrat primary, was the issue of proposed natural gas pipelines. It remains to be seen the degree of attention that issue will receive in the general election campaign. The choices made by Virginia voters on November 7 are important, but they were shaped by choices made in the June 13 primary. And, the number of people making those choices was . . . well . . . abysmal.

There 7 million persons of voting age in Virginia and 78% are registered. In last Fall’s Presidential election, the percentage of registered voters who cast ballots was 72% (56% of the voting age population). In last Tuesday’s primary elections to choose Republican and Democrat gubernatorial candidates, a total of 909,000 showed up to vote (543,000 in the Democrat Primary; 366,000 in the Republican Primary). That’s 16% of the registered voters in the Commonwealth and just under 13% of the voting age population.

We can do better. We must do better!
