## ABRA Update #171 – March 9, 2018

**Pipeline CSI Program Is Launched!** 



A near overflow crowd of 150 people gathered at the Staunton, VA Holiday Inn on March 3 to hear details about ABRA's new Pipeline Compliance Initiative (CSI). The program is designed to support citizen efforts to ensure strict application of environmental laws and regulations in the construction and operation of the Atlantic Coast Pipeline (ACP).

CSI will focus first on the approximately 200-mile section of the proposed ACP route extending from Harrison County in West Virginia to Buckingham County in Virginia. The extreme earth disturbance required for construction of the ACP in this area of steep mountain sides, highquality streams, and karst valleys presents an unacceptable risk to water resources.

The principal objectives of CSI are:

- To encourage and support citizen efforts to ensure strict application of environmental laws and regulations during pipeline construction across our steep mountains, karst valleys, high-quality surface waters, and vulnerable groundwater supplies.
- To successfully promote effective regulatory oversight of pipeline construction through collection and submission of evidence-grade information concerning noncompliance with, or failure of, required environmental protection practices.
- To evaluate, document, and communicate the performance limitations of required or available environmental protection practices during pipeline construction in extreme mountain landscape.

## Lawsuit Filed to Halt Construction of the ACP

The Southern Environmental Law Center (SELC) and Appalachian Mountain Advocates (Appalmad), on behalf of their client conservation and environmental groups, asked the Fourth Circuit U.S. Court of Appeals to halt construction by Atlantic Coast Pipeline (ACP) developers until it decides whether the Federal Energy Regulatory Commission's (FERC) permit is valid. The March 8 petition explains the issue to be resolved:

The Natural Gas Act requires FERC to rule on rehearing requests within thirty days, but FERC indefinitely postponed a ruling on Petitioner's Rehearing Request for the ACP. In the meantime, pipeline construction has begun and will irreparably harm Petitioners' property and environmental interests. Can this Court issue a writ pursuant to the All Writs Act staying construction of the ACP to preserve the status quo and its prospective jurisdiction under the Natural Gas Act?

### Tree-Felling for the ACP to Begin in National Forests, Expand Elsewhere

Permission for contractors of the Atlantic Coast Pipeline (ACP) to begin felling trees within the George Washington and Monongahela National Forests was granted by the U.S. Forest Service (USFS) on March 2. ABRA was informed of the decision during the course of a meeting with USFS officials to discuss the ABRA CSI program. The USFS had issued a Special Use Permit for the ACP in late January, but trees could not be felled until an additional permission was approved. Tree removal and other ground-disturbing activities are not yet authorized.

On Monday, March 5, the Federal Energy Regulatory Commission <u>expanded its permission</u> for tree felling in <u>Virginia</u> to within the 50-foot setback from wetlands and waterbodies that had been set forth in FERC's original authorization for cutting trees, <u>issued on February 16</u>, which required a 50-foot setback. The amended permission was granted by FERC in response to a request from Dominion Transmission, Inc., the managing partner for the ACP.

#### Stream Monitoring Webinars to Be Held March 13 and 27

A <u>Volunteer Pipeline Visual Assessment Program</u> has been developed by Trout Unlimited and the West Virginia Rivers Coalition to support and train volunteer citizen observers to identify, document and report pollution incidents associated with large-scale pipeline development. A series of free webinars have been scheduled for March 13 for Virginia residents and March 27 for West Virginians.

The webinars will instruct volunteers about erosion control best management practices used in pipeline development, specific examples of pollution to look for, and how to best document those problems. After the webinar, volunteer observers will be able to report pollution incidents to TU and WV Rivers. <u>To learn more, visit the program webpage</u>.

### Landowners Affected by ACP and MVP Urged to Sign Letter to Governor

Landowners whose property is directly affected by the Atlantic Coast Pipeline or the Mountain Valley Pipeline are being urged to sign on to a letter to Virginia Governor Northam. The letter notes examples of serious harm to property and the environment from pipeline projects elsewhere in the country and urges the Governor to "take action to prevent similar harms in Virginia. We believe that impacts to water quality, including drinking water sources and the Chesapeake Bay watershed, will be significant and sustained. Therefore we entreat you to fulfill your pledge that the pipelines be "held to the highest environmental standards."
