**Supplemental Information** 

Dear Secretary Bose:

By Order dated October 13, 2017, the Federal Energy Regulatory Commission (Commission or FERC) authorized Atlantic Coast Pipeline, LLC (Atlantic) and Dominion Energy Transmission, Inc. (DETI or "Dominion Energy") to construct and operate certain facilities that comprise the Atlantic Coast Pipeline and Supply Header Projects (Projects). *Atlantic Coast Pipeline*, *LLC & Dominion Energy Transmission*, *Inc.* 161 FERC ¶ 61,042 (the "Order").

As requested on May 16, 2018 (20180516-3074), Dominion Energy, on behalf of Atlantic and itself, hereby submits documentation that specifically identifies by milepost/stationing the habitat areas that will be avoided with respect to listed species covered by the U.S. Fish and Wildlife Service's (FWS) Incidental Take Statement for the Projects, and confirms the company's commitment to avoid construction in these areas. This information is provided in Attachment A. Dominion Energy will not undertake any activity identified in the Biological Opinion as likely to adversely affect protected species within construction areas until vacatur of the FWS Incidental Take Statement is resolved.

Dominion Energy requests that, pursuant to 18 C.F.R. § 388.112, the information filed in Attachment A be treated as controlled unclassified information and privileged and confidential, and that this information not be released to the public. As such, this information is labeled as "Contains Controlled Unclassified Information and Contains Privileged Information – Do Not Release" and contains the locations of sensitive species which are customarily treated as privileged and confidential.

Dominion Energy was unable to submit this filing yesterday because the FERC Online applications were unavailable, and is submitting it here as a paper submission because that unavailability continues. If you have any questions, please contact me at 866-319-3382.
