Augusta County Tables Proposal for ACP Storage Yard

A proposal for a storage yard to be built in western Augusta County to serve construction of the Atlantic Coast Pipeline (ACP) was tabled Thursday afternoon for 30 days by the county Board of Zoning Appeals (BZA). The site for the proposed yard is in the West Augusta area of the county, along U.S. 250. Another proposed storage yard for the ACP near Churchville was rejected by the BZA earlier this year. Opposition to the proposed yard was led by the Augusta County Alliance, an ABRA member organization. Compressor Station Air Permit Hearing Set for September 11

A public hearing before the Virginia State Air Pollution Control Board on <u>the proposed</u> <u>air permit for the Atlantic Coast Pipeline compressor station</u> in Buckingham County, VA (the only such facility planned in Virginia for the project) will be held next Tuesday, September 11, beginning at 5 pm at the Buckingham County Middle School, 1184 High School Road, Buckingham, VA. The hearing will cap a 30-day comment period that the Virginia Department of Environmental Quality announced in early August. Several requests have been made for the commit period to be extended, including a <u>September 5 letter</u> from the Southern Environmental Law Center that stated:

Virginia law provides that minor NSR permit applications are subject to a public comment period of *at least* 30 days. Va. Code § 5-80-1170. In light of the technical complexity and importance to the affected community of the proposed Buckingham compressor station, DEQ should exercise its statutory discretion to afford the public additional time to comment. We therefore ask that the comment deadline and public hearing be extended to Monday, October 8, 2018.

... the members of the public who stand to lose the most if the permit is insufficient to protect air quality are members of an economically disadvantaged minority community. The Virginia Energy Plan lists as one of the objectives of the Commonwealth's Energy Policy to "develop energy resources and facilities in a manner that does not impose a disproportionate adverse impact on economically disadvantaged or minority communities." Va. Code § 67-101(12). A step in the right direction in fulfilling that directive is to ensure the public has ample time to consider a permit that may very well impose just such a disproportionate impact on the Union Hill community.

West Virginia Considering Relaxing Stream Crossing Standards

The West Virginia Department of Environmental Protection (WVDEP) has opened a public comment period on proposed modifications to the West Virginia 401 Water Quality Certification for U.S. Army Corps of Engineers (USACE) Nationwide Permits, one of which is being proposed to assure that the conditions of the permit do not prevent a company from using more environmentally protective methods. Under WVDEP's proposed modifications to Special Condition C of the USACE Nationwide 12 Permit, a condition would be added to clarify that environmentally protective methods of stream crossings that take longer than 72 hours would be permitted.
