### **Large Turnout Shows for Air Board Hearing on ACP Compressor Station**

A crowd of over 150 persons attended a September 11 hearing in Buckingham, VA conducted by the Virginia State Air Control Board (SACB) to receive comments on the proposed compressor station for the Atlantic Coast Pipeline (ACP). The facility, which would be the only compressor station currently proposed for the ACP in Virginia, has been under widespread criticism because of the egregious impact it would have on the Union Hill community that is proximate to the proposed site and the nearby Yogaville Ashram and retreat center. Of the 85 persons presenting comments at the hearing, more than 80% were in opposition to the project. Most of those speaking in favor of the ACP project were from outside the affected community.

The public hearing was part of a comment period on the proposed air emissions permit for the project that has recently been extended to September 21. Those concerned about the compressor station's impact on air quality in Virginia are urged to submit written comments to the Department of Environmental Quality. Details on how to submit comments and a link to the draft air permit are available here.

The SACB is expected to vote on the compressor station air permit at its November 8-9 meeting.

### West Virginia DEP Invites Comments on Stream Crossing Permits

September 17 is the deadline for public input on proposed changes on the conditions under which stream crossings can be accomplished in West Virginia by the Atlantic Coast Pipeline and Mountain Valley Pipeline. Currently, projects like the two pipelines would be required to complete stream crossings within 72 hours, a standard that was adopted to minimize impacts to water quality and aquatic life. The proposed changes would relax that standard.

### **Governor Northam Announces Initiative to Target Pipeline Methane Leaks**

Virginia Governor Ralph Northam announced on September 12 the formation of a special workgroup to "develop a framework for limiting methane leakage from natural gas infrastructure and landfills." The announcement was part of an initiative to address climate change and ocean acidification. The <u>Governor's statement</u> says:

Natural gas has significant potential as a bridge fuel to help us reduce carbon pollution that drives climate change while we transition to solar, wind, and other clean energy sources. The relative climate benefits of natural gas compared to other fossil fuels are well documented, but we only realize those benefits if we prevent natural gas from leaking into the atmosphere before it is burned. For that reason, and due to inaction at the federal level, Virginia must take action to limit methane pollution within its borders.

The workgroup is to be composed of environmental, academic and business stakeholders and is to work with the state's Department of Environmental Quality to support the agency's "collection and evaluation of data to inform the regulatory process."

# Forest Service Proposes Relaxing Restrictions on Resource Extraction

Two rulemaking proposals published September 13 in the Federal Register would open national forests to increased energy and minerals extractions. The <u>first advanced notice of proposed rule-making</u>, seeks to "expedite energy-related projects by streamlining internal processes related to environmental review and permitting. . . The intent of these potential changes would be to decrease permitting times by removing regulatory burdens that unnecessarily encumber energy production. These potential changes would promote domestic oil and gas production by allowing industry to begin production more quickly."

The second advanced notice of proposed rule-making sets forth the following goals:

The goals of the regulatory revision are to expedite Forest Service review of certain proposed mineral operations authorized by the United States mining laws, and, where applicable, Forest Service approval of some of these proposals by clarifying the regulations, to increase consistency with the United States Department of the Interior, Bureau of Land Management (BLM) surface management regulations governing operations authorized by the United States mining laws to assist those who conduct these operations on lands managed by each agency, and to increase the Forest Service's nationwide consistency in regulating mineral operations authorized by the United States mining laws by clarifying its regulations .

Public comments on both proposed regulatory revisions must be received by October 15. Details on how to comment are contained in the respective Notices, which are linked above. After comments are evaluated, each proposal will be re-drafted and published as a proposed rule that will be available for further public comment.

# **Anti-Pipeline Sculpture to be Dedicated September 16**

A special sculpture expressing the concerns of people about the proposed Atlantic Coast Pipeline will be unveiled, installed and dedicated on Sunday, September 16, 1:30 to 3 pm, next to the Rockfish Valley Foundation Natural History Center, 1368 Rockfish Valley Highway in Nellysford, VA. The sculpture, titled The Defenders, was created by Mark Schwenk and Cheryl Langlais of Berkeley Springs, WV and is sponsored by the Climate Alliance of the Valley, Friends of Nelson and the Rockfish Valley Foundation.
