Fourth Circuit Hears Challenges to Forest Service and 401 Cases

A three-judge panel of the Fourth Circuit of the U.S. Court of Appeals in Richmond heard arguments last Friday, September 28, on two important cases challenging permits granted to the Atlantic Coast Pipeline (ACP). The first case challenged the December 13 decision by the Virginia State Water Control Board to grant a water quality certificate for the ACP (pursuant to requirements of Section 401 of the federal Clean Water Act). The second case challenged the decisions of the U.S. Forest Service (NFS) to amend the Forest Plans of the Monongahela National Forest (MNF) and the George Washington National Forest (GWNF) and to accordingly issue a Special Use Permit for the ACP to cross the two forests. The plaintiffs in both cases were a group of ABRA member organizations and others that were jointly represented by Appalachian Mountain Advocates (Appalmad) and the Southern Environmental Law Center (SELC). An article about the challenges appeared in the September 21 ABRA Update and includes links to each brief filed with the Court.

In the Forest Service case, the presiding judge noted that the Forest Service had been challenging ACP's ability to prove it could build the pipeline across steep mountain terrain without causing serious erosion problems. He noted that the record of correspondence and emails preceding the NFS decision indicated that a satisfactory response from the company had not been forthcoming. Then, suddenly in July 2017, the NFS issued a draft amendment to the Forest Plans of the MNF and GWNF and proceeded to approve the requested Special Use Permit. The judge inquired repeatedly of the attorney representing the NFS what the circumstances were that caused the Forest Service to change course. The attorney responded evasively, prompting the judge re-ask the question repeatedly, finally to thundering: "Who's running the train station? Is it the private company?" It was a riveting moment. MVP Has Another Permit Struck Down

The U.S. Army Corps of Engineers Huntington District's Nationwide Permit 12 for the Mountain Valley Pipeline (MVP) was vacated on October 2 by the Fourth Circuit Court of Appeals. At this time, the court's action only applies in West Virginia.

The case had been argued the previous Friday, September 28. The Court said that it agreed with the petitioners' claim that "in issuing its verification, the Corps improperly imposed one condition—requiring use of a 'dry cut' method for constructing four river crossings – in lieu

of a special condition imposed by the State of West Virginia, J.A. 23 – that that individual stream crossings must be completed in a continuous, progressive manner within 72 hours."

MVP informed the Federal Energy Regulatory Commission (FERC) on October 3 that:

Before the Court issued its order, Mountain Valley had commenced the process of crossing two streams in the Huntington District. Mountain Valley had installed flumes in the streams but had not yet started trenching. Mountain Valley has suspended the trenching work for these streams and is in the process of removing the flumes and completing any required stream bank restoration.

Also, on October 3, the plaintiffs in the case wrote FERC, arguing that the agency's October 13, 2017 certificate for the MVP "is no longer satisfied, requiring the Commission to take action to stop further construction activities" for the entire route, in WV and VA.

Augusta County Board Tables - Again - Proposal for ACP Storage Yard

The Augusta County, VA Board of Zoning (BZA) tabled the potential Dominion Pipeline storage yard yet again during its Thursday, October 4 meeting. Only three of the five members of the BZA were present. This is the fifth time and second location Dominion Energy has proposed a special use permit for a staging yard to build the Atlantic Coast Pipeline. Trump to Nominate Former McGuireWoods Partner to FERC Vacancy

Bernard McNamee, Executive Director of the Office of Policy for the U.S. Department of Energy, is to be nominated by President Trump to be a member of the Federal Energy Regulatory Commission, it was announced October 3 by the White House. He would fill the seat vacated by Commissioner Robert Powelson, who resigned from FERC in August to accept a position in the private sector.

Mr. McNamee was previously with the offices of the Attorneys General of both Virginia and Texas, served as a policy advisor to U.S. Sen. Ted Cruz and is a former partner with McGuireWoods, the Richmond-based law firm that includes Dominion Energy among its most prominent clients. He received his law degree from the University of Virginia.

According to Mr. McNamee's Linked-In profile, while with McGuireWoods he "represented electric and natural gas clients before state public utility, as well as providing advice related to major policy issues facing the energy industry."

In reporting on the announcement of McNamee's being named by President Trump, the publication *Utility Dive* noted: "During his time there, McNamee <u>wrote an Earth Day op-ed for The Hill</u> extolling the virtues of fossil fuels, writing that 'some suggest that we can replace fossil fuels with renewable resources to meet our needs, but they never explain how."

Virginia Energy Plan 2018 Unveiled

Virginia Governor Ralph Northam released on October 2 the 2018 Virginia Energy Plan. In his announcement release, the plan was described as providing "a strategic vision for the Commonwealth's energy policy over the next 10 years. With a focus on modernizing the electric grid and promoting innovative technologies, the plan sets goals for renewable energy generation, energy efficiency, and electric vehicles."
