I am writing on behalf of the Board of Supervisors of Nelson County, Virginia to submit the Board's formal request to the Federal Energy Regulatory Commission (FERC) for the conduct of a second public meeting in Nelson County by FERC on the Atlantic Coast Pipeline Project (ACP Project) prior to the conclusion of the ACP Project's present scoping period.

The Board of Supervisors formally approved by unanimous vote (all members present) the request, as stated herein above, during a public session conducted on March 26, 2015 in the Nelson County Courthouse in Lovingston, Virginia.

The Board is concerned that the public meeting conducted in Nelson County by FERC on March 18, 2015 did not provide sufficient time for receipt of public comment during the scoping meeting. The Board is also concerned that the Atlantic Coast Pipeline, LLC's very recent presentation of alternative routes for the ACP Project did not enable those parties (residential, commercial, etc.) located along the new alternative routes sufficient time to prepare and present public comment to FERC at the 3-18-15 project scoping meeting in Nelson County and, as such, this too warrants the conduct of a second public meeting by FERC in Nelson County.
