ACP Construction Yard in Goshen Approved by County Planning Commission

The Rockbridge County, VA Planning Commission approved on May 13 a site plan for a proposed construction storage yard for the Atlantic Coast Pipeline (ACP) in Goshen, VA. The 4-0 vote (with one abstention) came despite 95 of the 99 written comments received by the Commission expressing opposition to the yard plan. The County Board of Supervisors is scheduled to consider the issue on May 26. (See earlier *ABRA Update* article here.)

ACP Responds to Buckingham Compressor Station Court Decision

Atlantic Coast Pipeline, LLC (ACP, LLC) has finally submitted a response to the <u>January 7 decision by the Fourth Circuit Court of Appeals</u> to vacate the Buckingham compressor station. ACP, LLC made recently two supplemental information submissions to the Virginia Department of Environmental Quality (DEQ), each responding to different issues raised by the Fourth Circuit.

An <u>April 24 submission to DEQ</u> responded to the issue of "why electric turbines are not required to be considered in Virginia's BACT [Best Available Control Technology] analysis of the Compressor Station." The <u>company's April 30 submission</u> addressed the Court's concern about "conflicting evidence in the record, the particular studies it relied on, and the corresponding *local character and degree of injury* from particulate matter and toxic substances threatened by construction and operation of the Compressor Station." It is uncertain when the matter will be taken by the Virginia Air Pollution Control Board, as that body has not yet scheduled a meeting to reconsider the project's air permit.

Army Corps Appeals Court Decision Vacating NWP12 Program

The U.S. Army Corps of Engineers filed on May 13 an appeal with the Ninth Circuit Court of Appeals of the Montana U.S. District Court of the decision that vacated the authority of the Corps to issue new stream crossing permits under the Corps' Nationwide 12 program. The April 15 decision impacts both the Atlantic Coast Pipeline and the Mountain Valley Pipeline, as neither project has a valid NWP12 permit at this time. At this writing, the Ninth Circuit has not indicated when the appeal will be considered.

FERC Rejects State AGs Plea for Project Moratorium During COVID-19 Crisis

A May 7 request by attorneys general of 10 states and the District of Columbia for a moratorium on approvals of all new and pending natural gas pipelines, LNG facilities and related fossil-fuel infrastructure projects during the COVID-19 pandemic has been summarily rejected by the Chairman of the Federal Energy Regulatory Commission (FERC). The AGS'S letter argued that a moratorium is "necessary to preserve the due process rights of interested parties, many of whom are dealing with unprecedented challenges to their health and economic wellbeing from the COVID-19 crisis and whose ability to participate in hearings and proceedings may be accordingly constrained."

FERC Chairman Neil Chatterjee replied on <u>May 12 in a letter to Virginia AG Mark Herring</u>, denying the moratorium request. Chatterjee said:

"Hindering the build-out of energy infrastructure now could have long-term and lasting negative impacts on the delivery of energy in the future. For these reasons, I view requests for a moratorium on energy projects to be short-sighted and impractical. Any step to slow the energy economy is a step in the wrong direction."
