Re: September 17, 2021 Quarterly State Air Pollution Control Board Meeting and Mountain Valley Pipeline's "Lambert Compressor Station" Air permit, Registration No. 21652

Dear Director Paylor,

Appalachian Voices and the undersigned organizations write again to express serious concerns about the public engagement and participation process for the Lambert Compressor Station (LCS) air permit—specifically, public access to the September 17, 2021 meeting of the State Air Pollution Control Board, during which a case decision on the permit is expected.

Members of the public and the Board have expressed concerns about public access to the proceedings, and transmission of COVID-19 is quickly rising in the Commonwealth again; therefore, we ask that you provide a virtual option for public participation in the meeting. Citizens must be provided with safe and equitable access in order to ensure a fair, open, and transparent process.

Hundreds of citizens, including directly impacted community members, submitted comments on the proposed LCS permit. To facilitate their participation in the process, we reiterate that it would be reasonable for DEQ to (1) include remote or virtual participation options, (2) hold the meeting over two days to accommodate the large number of commenters, (3) provide the option for written submissions from commenters unable to attend in person to be read by their on-site proxies, and (3) include both daytime and evening opportunities for public participation.

As noted in a July 25 letter from the Pittsylvania County NAACP, without a virtual meeting option, members of the community impacted by the proposed LCS will be required to travel several hours to the potential meeting location in Richmond. Moreover, holding an in-person meeting while COVID-19 transmission rates are sharply rising is likely to hinder public participation.

We remind you that *meaningful involvement*, as defined in the Virginia Environmental Justice Act, requires that "community residents have access and opportunities to participate in the full cycle of the decision-making process about a proposed activity that will affect their environment or health."

The meeting as currently designed fails to allow for meaningful public participation or engagement. Accordingly, we renew our request that the Department offer an opportunity for virtual participation by the public during the September 17, 2021 quarterly meeting of the State Air Pollution Control Board.
